

**Instructions for Completing UPS Worldwide Forwarding, Inc. Exporter / Principal Party
in Interest Power of Attorney**

STEP ONE:	Provide certain Grantor / Principal Party in Interest (PPI) information.
(1)	State the Employer Identification Number (EIN), also known as the federal tax identification number, of the Grantor / PPI.
(2)	State the Grantor's / PPI's Data Universal Number System (DUNS) number.
(3)	Provide the Grantor's / PPI's UPS shipper number. If not known, please leave this blank.
(4)	Print (or type) the name of the Grantor / PPI. It must be the full legal name associated with the registered Employer Identification or Social Security number. If other than a corporation, list either LLC, individual, general partnership, limited partnership, or sole proprietorship. If none of those apply, please contact your UPS/WWF representative.
(5)	List the state or, if a foreign Grantor / foreign PPI, the country and province in which the foreign Grantor / foreign PPI is doing business
(6)	Provide the complete address where the Grantor / PPI resides.
STEP TWO:	Sign and date the Power of Attorney.
(7)	Signature of a duly authorized person of the company. <u>Note:</u> The form must be signed by a duly authorized person of the Grantor / PPI (i.e., President, Treasurer, Vice President, Corporate Secretary, CEO, CFO, CIO, COO). By signing this document, the signatory attests that he or she has authority to issue this power of attorney on behalf of the company.
(8)	Indicate the capacity of the signatory (title) (i.e., President, Vice President, Treasurer, Corporate Secretary, CEO, CFO, CIO, COO, Partner, Member, Director of other Duly Authorized Representative).
(9)	Write the date on which the signatory signed the Power of Attorney.
STEP THREE:	Return the Power of Attorney to UPS Worldwide Forwarding, Inc.
(10)	Send the signed original to United Parcel Service, Inc. at the address listed or fax the signed original to 1-888-895-4189.

hereby authorizes UPS Worldwide Forwarding, Inc. and its affiliates (“Forwarding Agent”), its successors or assigns, to act for and on its behalf as a true and lawful agent and attorney of the PPI, from this date, in the United States either in writing, electronically, or by other authorized means to:

Act as Forwarding Agent for export control, Bureau of the Census reporting, and customs purposes, and to make, endorse, sign or file Electronic Export Information (“EEI”) through the Automated Export System (“AES”) or to perform any act which may be required by law in connection with the exportation or transportation of any merchandise shipped or consigned by or to the PPI and to receive or ship any merchandise on behalf of the PPI.

The PPI hereby certifies that all statements and information contained in the documentation provided to the Forwarding Agent relating to the exportation or transportation are true and correct. Furthermore, the PPI acknowledges that it is responsible for determining export licensing requirements and obtaining licensing authority. The PPI understands that civil and criminal penalties may be imposed for making false or fraudulent statements or for the violation of any United States laws or regulations on exportation.

The PPI agrees that by executing this document, it is subject to the most current version of the UPS Tariff/Terms and Conditions of Service, which are published in printed form in the UPS Rate & Service Guide and electronically on the UPS web site (ups.com®). The most current version of the UPS Tariff/Terms and Conditions of Service are subject to change without prior notice. The PPI agrees that the most current version of the UPS Tariff/Terms and Conditions of Service in effect at the time PPI tenders a shipment for the use of Forwarding Agent’s services will apply to that shipment, the PPI and Forwarding Agent.

If the PPI tenders a shipment for the use of Forwarding Agent’s services through a UPS automated shipping system such as UPS Worldship™, then the PPI agrees that the terms and conditions of the UPS Technology Agreement that grants a limited license to use that UPS automated shipping system will also apply to that shipment, the PPI and Forwarding Agent.

UPS Worldwide Forwarding , Inc. acknowledges that during the performance of its duties, it will be in compliance with applicable laws governing its role in the shipment of products for export from the United States of America.

This power of attorney is to remain in full force and effect until the date revocation in writing is duly given by the PPI and received by Forwarding Agent.
