Charge	Description	Rate
De Minimis	Shipment value of USD\$1.00 to USD\$50.00	No charge
Global Pedimento (Pedimento Global)	A fee for every shipment with a value between USD\$50.01 and USD\$300.00 will apply. This fee applies for every individual air waybill	MXN\$123.92
T1 Pedimento (Pedimento T1)	A fee for every shipment with a value between USD\$300.01 and USD\$1,000.00 will apply. This fee applies for every individual air waybill	MXN\$640.04
Individuals	A fee for every shipment cleared as an individual pedimento under the importer's or shipper's name will apply. This fee applies for every individual air waybill	MXN\$640.04
Export Individual Pedimento	A fee for every shipment cleared as an individual pedimento under the importer's or shipper's name will apply. This fee applies for every individual air waybill	MXN\$640.04
Urgent Clearance	Expedite clearance of the shipments	MXN\$1,008.53
Remesa on a consolidated pedimento	Fee to consolidate more than one waybill in a pedimento	MXN\$532.29
Financing Fee	Fee for financing import duties	3% of the financed amount Maximum charge MX\$3,500
Additional lines	This fee applies when the sum of the invoices or lines in the invoice exceeds 10 lines	MXN\$28.05 per additional line for Mexico City, Monterrey, Guadalajara y Colombia MXN\$31.27 per additional line for Tijuana, Cancun y Merida
Mutilation of Goods/Inspection	Fee applies when a good needs to be mutilated	MXN\$346.98 per package for Mexico City, Monterrey, Guadalajara y Colombia MXN\$369.59 per package for Tijuana, Cancun y Merida
Warehouse	This charge applies when two business days have passed since the shipper has been notified about the arrival of the goods, and the shipment hasn't been cleared	MXN\$71.14 per day per package
Copy of the Pedimento	A fee applies for every copy of the pedimento requested after three months of being cleared	MXN\$72.23 per copy
Labeling	A fee applies when a product needs to be labeled using self-adhesive labels for clearance purposes	USD\$0.93 per label
Rectification of Pedimento	Fee applies when a pedimento has to be corrected due to an error caused by the customer or the vendor	MXN\$484.85 per pedimento for Mexico City, Monterrey, Guadalajara y Colombia MXN\$516.11 per pedimento for Tijuana, Cancun y Merida
Copy of Clearance File	Fee applies for every requested copy of the clearance file	MXN\$376.15 per copy
Baggage release	Fee applies for clearance of baggage. Cost per pedimento	MXN\$2,078.41 per pedimento
Operations with Government agencies: (PROFEPA, SAGARPA [except MTY], etc.)	Fee applies for every procedure	MXN\$2,078.41 per transaction
Recovery from Abandonment	Fee applies to clear any shipment that was already in abandonment	MXN\$1,948.06 per shipment
Held for Custody	Fee applies for keeping goods under custody based on the value of the goods	Review rates directly on the airport of choice
"Previo" = Audit of Brokerage Document	Fee applies to compare what is in the invoice against the real shipment	Review rates directly on the airport of choice
Third Party Broker	Fee applies when rights are given to a broker different than UPS to clear the goods	Review rates directly on the airport of choice
Handling	Fee applies for the handling done in order to dispatch the goods to another broker	Review rates directly on the airport of choice
