

## **Terms and Conditions – UPS Intra-Asia New Year Promotion Program**

This promotion (“Promotion”) is valid for eligible intra-Asia export shipments from China<sup>1</sup> using the following services where available, UPS Worldwide Express Plus™, UPS Worldwide Express™, UPS Worldwide Express Saver®, UPS Worldwide Expedited™, and/or UPS Worldwide Express Freight® services, and will run from 10 January 2019 to 30 March 2019.
2. Promotion code must be entered at time of shipment. To redeem the promotion code, shipments must be made using UPS Internet Shipping on ups.com between 12:01 am on 10 January 2019 and 11:59 pm on 30 March 2019, China time (GMT+8). Shipments made online by 30 March 2019 must be tendered to UPS by 9 April 2019 to be eligible. Shippers must have a valid UPS ID to be eligible. Promotion code may not be applied to past shipments or credited toward future processing. Offer is void where prohibited or restricted by law. No cash value. Eligible services and discounts are subject to change. The Promotion cannot be combined with any other offer or existing pricing incentives.
3. The shipping discounts offered under this Promotion are not applicable to third-party shipments and non-standard services such as shipments with special request(s) or consolidated clearance. The shipping discounts are also not applicable to shipments exceeding 2,000 kg (in either actual or dimensional weight), UPS 10 KG Box and UPS 25 KG Box. Shipments exceeding 2,000 kg will be charged at the published rate. All standard terms, conditions, and procedures applicable to shipments exceeding 2,000 kg shall continue to apply.

Upon valid redemption of promotion code, applicable shipping discounts will automatically be applied to the published rates in the effective UPS Rate and Service Guide on ups.com for eligible intra-Asia export shipments from China<sup>1</sup> processed with either (i) credit card or (ii) a UPS account number. For UPS accounts with a pricing agreement, upon successful application of promotion discount, any existing pricing agreement rate for the UPS account number will not apply to the shipment. Promotion code cannot be applied in addition to any negotiated rates savings. Promotion code is also not valid for shipments billed to a receiver or third party. Shipping discount will only apply to freight charges. All other charges, including but not limited to accessorial charges and fuel surcharges, shall continue to
