DANGEROUS GOODS - DOMESTIC	A dangerous good (also known as hazardous material or hazmat) is any substance or material that is capable of posing an unreasonable risk to health, safety, and property when transported in commerce.	\$0.49 per lb; \$122.00 Minimum
NON-CONFORMING FREIGHT	Shipments that are unusually shaped, non-stackable, difficult to handle or require special handling in transit (to prevent damage to the shipment, the other shipments it may come in contact with or the equipment). Non-conforming freight may be subject to service delays and additional charges.	30% of Air Freight; \$260.00 Minimum
NYC SURCHARGE - DEST/ORIG	Shipments to or from New York City	\$200.00 per shipment
OVERSIZE FEE	Fee for shipments whose girth exceeds 200 inches, any dimension exceeds 60 inches.	Cubic Dimensional Weight and % of transportation charge for the greater of: – 20% if length + girth > 200" – 30% if a dimension > 60" – Minimum \$205.00 when a dimension > 120" between U.S., Canada, and Puerto Rico – Minimum 205.00 CAD when a dimension > 120" intra-Canada
PREMIUM CITY FEE-ORIGIN / DESTINATION**	Applies outbound from or inbound to select origin or destination tariff points in the U.S., & Canada.	\$200.00 per shipment
RESIDENTIAL PICKUP / DELIVERY	Fee assessed for pickup from or delivery to a home address including a business operating out of a home that does not have an entrance open to the public.	\$170.00 per shipment between U.S., Canada, and Puerto Rico 170.00 CAD per shipment intra-Canada
Redelivery	If more than one delivery attempt is made.	\$0.082 per lb; \$75.00 Minimum
Special Handling Origin/Destination	When additional, non-routine activities/services are required, selected services may be performed by UPS. – Services offered include (but are not limited to) manipulations, labeling, inventory, auditing, customized reports, spreadsheets, key entry, general order processing, etc.	\$109.50 per shipment between U.S., Canada, and Puerto Rico 109.50 CAD per shipment intra-Canada
Liftgate Services	– Liftgate equipment on trailers is available for customers who do not have a shipping or receiving dock and cannot load or unload their shipment without liftgate assistance – Liftgate service must be requested, as not all trailers are equipped with liftgate devices	– Origin: \$9.90 per 100 lbs.; \$146.00 Minimum; \$451.00 Maximum – Destination: \$9.90 per 100 lbs.; \$146.00 Minimum; \$451.00 Maximum
Declared Value/Valuation Charge	UPS's liability for all losses is limited to \$50.00 per shipment or \$0.50 per pound, whichever is greater. – Shipper may declare a value in excess of these limits, subject to maximum allowable values for an additional charge. – For more information, refer to the "UPS Air Freight Terms and Conditions of Contract for UPS Air Freight Services in the United States, Canada and International" at ups-scs.com/terms .	\$1.20 per \$100.00 of Declared Value (\$120.00 Minimum between U.S., Canada, and Puerto Rico)
