



# UPS® Ground with Freight Pricing Pricing Provisions and Service Availability

*Effective November 15, 2021*

## Pricing Provisions

UPS Ground with Freight Pricing is available to customers shipping within the contiguous 48 states.

The minimum charge applicable to any shipment will be the greatest of the (1) UPS Ground with Freight Pricing Base Rates, (2) Per Package Minimum multiplied by the number of individual pieces, or (3) Absolute Minimum Charge.

To determine your rate, follow the steps below:

- 1) UPS Ground with Freight Pricing Base Rates are obtained by applying the applicable discount based on weight to the rates in the UPS Freight 560 Series tariff in effect at the time of shipping between points in the 48 contiguous states. Rating is based on actual Freight Class.
  - a. For shipments weighing up to and including 500 lbs., an 80% discount applies
  - b. For shipments weighing 501 lbs. or more, a 65% discount applies

### To view the base rates for a shipment, take the following steps:

1. Visit <https://www.ups.com>.
2. Select Log In. If you have a User ID and password, enter that information and select Log In. Otherwise, select Sign Up and complete the sign up process to obtain a User ID and password.
3. Select Quick Start and then Quote.
4. Select the Freight tab.
5. Select Ground Freight (Less-Than-Truckload)
6. Enter Ship From and Ship To information. Select Shipment Date, Payment Term, and Relation to Shipper.
7. Enter origin ZIP Code located within the 48 contiguous states.
8. Select the Next button.
9. Enter applicable discount based on weight of the shipment.
10. Enter Freight Class and then the weight and number of packages corresponding to that freight class.
11. Populate any additional fields as necessary (e.g., weight of pallets, accessorials)
12. Select the Next button.
13. Select Show Details link.
14. The Amount After Discount in the UPS Ground with Freight Pricing is the UPS Ground with Freight Pricing base rate.

If the base rate is unavailable online, you will be directed to call to obtain the rate.

- 2) The Per Package Minimum is determined by calculating the rate applicable to 1 lb. packages shipped via UPS Ground service for Zone 2, as specified in the UPS Daily Rate and Service Guide in effect at the time of shipping, available at [ups.com](https://www.ups.com).
- 3) Effective November 15, 2021, the Absolute Minimum Charge (Floor Minimum) is \$93.50 per shipment.
- 4) UPS Ground with Freight Pricing shipments are subject to Value-Added Services charges and Other Charges as indicated in the UPS Rate and Service Guide applicable to small package shipments, including but not limited to the Fuel Surcharge applicable to UPS Ground service. Unless otherwise noted, Value-Added Services charges and Other Charges are per package for UPS Ground with Freight Pricing Service.

## Service Availability

UPS Ground with Freight Pricing is available for shipments within the 48 contiguous states.

Hazardous Materials Shipments are not accepted for transportation via UPS Ground with Freight Pricing service.

UPS Ground with Freight Pricing is not available for UPS Returns® Services packages.
