

UPS® Peak Surcharges

April 6, 2020 Update

UPS will continue service amid the ongoing coronavirus outbreak to support the demand and needs of our customers. Our goal is to ensure businesses and customers are able to meet their shipping needs as the demand for air cargo capacity increases.

UPS Peak Surcharges

As previously announced, a Peak Surcharge will apply to shipments from China Mainland or Hong Kong SAR to Puerto Rico effective April 5, 2020 until further notice. Effective April 12, 2020 until further notice, the amount of this Peak Surcharge will increase and additional Peak Surcharges will apply to shipments with other origins and/or destinations, as market conditions have continued to evolve with the ongoing coronavirus situation.

Peak Surcharges are subject to change and Peak Periods may be extended or otherwise changed. Shippers should continue to check ups.com for updates prior to tendering shipments.

Peak Surcharges will apply to packages shipped during the specified Peak Periods for the origins, destinations, and service levels and in the amounts set forth below. Peak Surcharges apply in addition to all other applicable Charges. The UPS Fuel Surcharge is calculated also on the Peak Surcharges.

A. Peak Surcharge – Applied to shipments from China Mainland or Hong Kong SAR to Puerto Rico

The Peak Surcharge that will apply to any shipment originating from China Mainland or Hong Kong SAR to Puerto Rico will apply from April 5, 2020 until further notice for the Service Levels and Peak Periods set forth below. The Peak Surcharge will be applied as a rate per kilogram or per pound based upon the billable weight of the shipment.

B. <u>Peak Surcharge</u> – Applied to any pre-paid air service shipments originating from Puerto Rico to all international destinations and any import shipments coming into and invoiced in Puerto Rico (e.g. import freight collect shipments)¹ (except China Mainland and Hong Kong SAR)

The Peak Surcharge will apply from April 12, 2020 until further notice for the Service Levels and Peak Periods set forth below. The Peak Surcharge will be applied as a rate per kilogram or per pound based upon the billable weight of the shipment. Peak Surcharges applicable to shipments originating from China Mainland or Hong Kong SAR are set forth in section A above.
