



UPS® Peak Surcharges

May 15, 2020 Update

UPS will continue service amid the ongoing coronavirus outbreak to support the demand and needs of our customers. Our goal is to ensure businesses and customers are able to meet their shipping needs as the demand for air cargo capacity increases.

UPS Peak Surcharges

As previously announced, a Peak Surcharge will apply to shipments from China Mainland or Hong Kong SAR to Puerto Rico effective April 12, 2020 until further notice. Effective May 24, 2020 until further notice, the amount of this Peak Surcharge will increase as market conditions have continued to evolve with the ongoing coronavirus situation. The Peak Surcharge applied to international shipments from all other origins will continue to apply. Peak Surcharges are subject to change and Peak Periods may be extended or otherwise changed. Shippers should continue to check [ups.com](https://www.ups.com) for updates prior to tendering shipments.

Peak Surcharges will apply to packages shipped during the specified Peak Periods for the origins, destinations, and service levels in the amounts set forth below. Peak Surcharges apply in addition to all other applicable Charges.

A. **Peak Surcharge** – Applied to shipments from China Mainland to Puerto Rico

The Peak Surcharge that will apply to shipments originating from China Mainland to destinations in Puerto Rico, and paid for in Puerto Rico, will apply from April 12, 2020 until further notice for the Service Levels and Peak Periods set forth below. The Peak Surcharge will be applied as a rate per kilogram or per pound based upon the billable weight of the shipment.

The Peak Surcharge that will apply to shipments originating from Hong Kong SAR to destinations in Puerto Rico, and paid for in Puerto Rico, will apply from April 12, 2020 until further notice for the Service Levels and Peak Periods set forth below. The Peak Surcharge will be applied as a rate per kilogram or per pound based upon the billable weight of the shipment.

The Peak Surcharge will be applied as a rate per kilogram or per pound based upon the billable weight of the shipment.
