### **North American Air Freight Fuel Surcharge**

UPS Supply Chain Solutions uses an index-based fuel surcharge for North American Air Freight that is adjusted bimonthly. The surcharge is based on an average of the weekly prices of the *U.S. Gulf Coast Spot Prices for Kerosene-Type Jet Fuel* as reported by the US Department of Energy for the two weeks prior to the adjustment. Changes to the fuel surcharge are effective on the first and fifteenth of each month. The fuel surcharge for October 1st is \$0.260/lb. based on the prior two week's *U.S. Gulf Coast Spot Prices for Kerosene-Type Jet Fuel* of \$0.998 per gallon.
