



# UPS® Fuel Surcharges

## Export Air Fuel Surcharge

UPS uses an index-based surcharge that is adjusted weekly. Changes to the surcharge will be effective on Monday of each week. The surcharge will be based on the U.S. Gulf Coast (USGC) price for kerosene-type jet fuel as most recently released by the U.S. Energy Information Administration (EIA) rounded to the nearest cent. For example, the surcharge for the week of August 29, 2022 is based on the U.S. Gulf Coast (USGC) price for kerosene-type jet fuel released by the EIA the week of August 22, 2022.
