UPS Demand Surcharges

UPS will continue service amid the ongoing coronavirus outbreak to support the demand and needs of our customers. Our goal is to ensure businesses and customers are able to meet their shipping needs as the demand for air cargo capacity increases.

Since April 12, 2020, a Demand Surcharge has been applicable to international shipments.

This is an evolving situation and since then the temporary surcharge has been subject to changes due to market conditions and may be extended or otherwise changed. Shippers shall continue to check [ups.com](https://www.ups.com) for updates prior to tendering shipments.

Effective September 25, 2022 until further notice, the amount of the Demand Surcharge applied to shipments from the U.S. to India will *increase*. All other previously announced Demand Surcharges remain unchanged.

Demand Surcharges will apply to all packages above 0.5kg, including letters and documents shipped for the origins, destinations, and service levels in the amounts set forth below. Demand Surcharges apply in addition to all other applicable Charges.

Current UPS Demand Surcharges in effect

A. Demand Surcharge – Applied to shipments from China Mainland, Hong Kong SAR, Macau SAR to India

The Demand Surcharge for any shipment originating from China Mainland, Hong Kong SAR, Macau SAR to India increased effective May 1, 2022 until further notice for the Service Levels set forth below. Effective August 14, 2022 the Demand Surcharge for WVEF shipments will decrease.

The Demand Surcharge will be applied as a rate per kilogram based upon the billable weight of the shipment.

B. Demand Surcharge - Applied to shipments from India to Australia and New Zealand

The Demand Surcharge for any shipment originating from India to Australia and New Zealand increased effective June 19, 2022 until further notice for the Service Levels set forth below.

The Demand Surcharge will be applied as a rate per kilogram based upon the billable weight of the shipment.

C. Demand Surcharge - Applied to shipments from other major Asia Pacific origins¹ to India

The Demand Surcharge for any shipment originating from other major Asia Pacific origins¹ to India increased effective May 1, 2022 until further notice for the Service Levels set forth below. Effective August 14, 2022 the Demand Surcharge for WWEF shipments will decrease. WWEF Imports from New Zealand remain the same.

The Demand Surcharge will be applied as a rate per kilogram based upon the billable weight of the shipment.

D. Demand Surcharge – Applied to shipments from select Europe² origins to India

The Demand Surcharge for any shipment originating from select Europe² origins to India increased effective March 20, 2022 until further notice for the Service Levels set forth below.

The Demand Surcharge will be applied as a rate per kilogram based upon the billable weight of the shipment.

The Demand Surcharge for shipments from all other origins (excluding shipments from countries outlined above and below) to all other destinations increased effective June 19, 2022 for the Service Levels set forth below.

The Demand Surcharge will be applied as a rate per kilogram based upon the billable weight of the shipment.

F. Demand Surcharge – Applied to shipments from India to North America³

The Demand Surcharge for express shipments originating from India to North America³ increased effective January 30, 2022 for the Service Levels set forth below.

UPS Worldwide Express Freight® and UPS Worldwide Express Freight® - MIDDAY remain unchanged.

The Demand Surcharge will be applied as a rate per kilogram based upon the billable weight of the shipment.

The Demand Surcharge will be applied as a rate per kilogram based upon the billable weight of the shipment.
