



UPS[®] Worldwide Economy Peak Surcharges & Temporary Service Suspensions

Due to recent market developments amid the ongoing Coronavirus outbreak, a Peak Surcharge will apply to UPS Worldwide Economy **DDP** shipments from the export sites to the destinations set forth below, during the specified effective dates. Shipments will be rated with the Peak Surcharge in effect at the time the shipments receive their first scan by UPS at the UPS Worldwide Economy export site. Peak Surcharges will be applied as a rate per pound based upon the billable weight of the shipment.

The Peak Surcharges listed below will be added to your current net rate for applicable UPS Worldwide Economy **DDP** shipments and included in the transportation rate for purposes of calculating the fuel surcharge. The Peak Surcharges will be included as a separate line item on your UPS invoice. Peak Surcharges apply in addition to all other applicable charges. No waiver, discount, or reduction of any type to the Peak Surcharges shall apply unless UPS agrees in writing to such waiver, discount, or reduction with specific written reference to the Peak Surcharges.

Temporary Service Suspensions

Due to Coronavirus impacts on global postal transportation networks, we are no longer able to process UPS Worldwide Economy **DDU** packages to certain countries. Service to the destinations listed below is temporarily suspended, effective immediately until further notice. Any UPS Worldwide Economy **DDU** packages received by UPS to these destinations during these service suspensions will be consolidated and returned to the shipper twice a week using UPS Ground service, charged to the shipper's UPS account number. Shippers will be responsible for all charges associated with returned shipments. Other destinations not affected by these service suspensions are experiencing delays in transportation and delivery once the packages have arrived in country.
