September 9, 2022 Update

UPS continues to provide essential service amid the ongoing coronavirus outbreak to support the needs of our customers. Our goal is to ensure businesses and customers are able to meet their shipping needs while demand has increased for shipping services.

UPS Peak/Demand Surcharges¹

One or more Peak/Demand Surcharges will apply to packages shipped during the specified Peak/Demand Periods for the origins, destinations, and service levels and in the amounts set forth below. Peak/Demand Surcharges apply in addition to all other applicable Charges.

Peak/Demand Surcharges are subject to change and Peak/Demand Periods may be extended or otherwise changed. Shippers should continue to check [ups.com/peaksurcharge](https://www.ups.com/peaksurcharge) for updates prior to tendering shipments.

A. Peak/Demand Surcharge – Applied to shipments from China Mainland, Hong Kong SAR or Macau SAR to the U.S.²

A Peak/Demand Surcharge will apply to shipments originating from China Mainland, Hong Kong SAR or Macau SAR to the U.S. until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge for shipments to the U.S. will be applied as a rate per pound based upon the billable weight of the shipment.

B. Peak/Demand Surcharge – Applied to shipments from Australia, New Zealand, or other Asia origins to the U.S.

A Peak/Demand Surcharge will apply to any shipment from Australia, New Zealand, Vietnam, Japan, Korea, Malaysia, Thailand, Indonesia, Singapore, Philippines, or Taiwan to the U.S. until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

C. Peak/Demand Surcharge – Applied to shipments from the U.S. to Australia or New Zealand

A Peak/Demand Surcharge will apply to any shipment from the United States to Australia or New Zealand until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

D. Peak/Demand Surcharge – Applied to shipments from Europe origins to the U.S. or North America

A Peak/Demand Surcharge will apply to any shipment from Austria, Belgium, Czech Republic, Denmark, Finland, France, Germany, Hungary, Ireland, Italy, Luxembourg, Netherlands, Norway, Poland, Portugal, Spain, Sweden, Switzerland, or United Kingdom to the U.S. or North America until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

E. Peak/Demand Surcharge – Applied to shipments from India to the U.S. or North America

A Peak/Demand Surcharge will apply to any shipment from India to the U.S. or North America until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

F. Peak/Demand Surcharge – Applied to UPS Standard shipments from Canada to the U.S. and UPS Trade Direct[®] shipments from the U.S. to Canada

A Peak/Demand Surcharge will apply to all packages shipped UPS Standard to the U.S. and UPS Trade Direct[®] from the U.S. to Canada until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per package.

G. Peak/Demand Surcharge – Applied to international shipments from Mexico to all destinations (except Australia and New Zealand)

A Peak/Demand Surcharge will apply to any international shipment from Mexico to all destinations, except shipments to Australia and New Zealand, until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

H. Peak/Demand Surcharge – Applied to international shipments from the U.S. to Canada

A Peak/Demand Surcharge will apply to all packages shipped from the U.S. to Canada until further notice, for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment, excluding UPS Standard to Canada. The Peak/Demand Surcharge for UPS Standard to Canada will be applied as a rate per package.

I. Peak/Demand Surcharge – Applied to international shipments from the U.S. to Europe

A Peak/Demand Surcharge will apply to all packages shipped from the U.S. to Europe, until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

J. Peak/Demand Surcharge – Applied to international shipments from the U.S. to all destinations (except Australia, Canada, Europe and New Zealand)

A Peak/Demand Surcharge will apply to all packages shipped from the U.S. to all destinations except Australia, Canada, Europe and New Zealand until further notice, for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

K. Peak/Demand Surcharge – Applied to international shipments from all origins to all destinations (except shipments covered in Sections A-J above)

A Peak/Demand Surcharge will apply to any international shipment from all origins to all destinations, except shipments subject to the Peak/Demand Surcharges set forth in Sections A through J above, until further notice for the Service Levels and Peak/Demand Periods set forth below. The Peak/Demand Surcharge will be applied as a rate per pound based upon the billable weight of the shipment.

L. Peak/Demand Surcharge – Applied to Additional Handling and Large Packages

A Peak/Demand Surcharge will apply to packages that require Additional Handling³ and Large Packages³ for all U.S. domestic, U.S. import, and U.S. export shipments for qualifying customers.⁴ A Peak/Demand Surcharge will apply to all packages that are Over Maximum Limits for all U.S. domestic, U.S. import, and U.S. export shipments. The Peak/Demand Surcharges will apply in the amounts set forth below.

M. Peak/Demand Surcharge – Applied to UPS[®] Ground Residential and UPS SurePost[®] Packages

A Peak/Demand Surcharge will apply to certain UPS Ground Residential⁵ and UPS SurePost packages for all U.S. domestic shipments, for qualifying customers who have shipped more than 25,000 packages during any week following February 2020.⁶ The Peak/Demand Surcharge will apply in the amounts set forth below on a per package basis to the indicated service levels during the specified Peak/Demand Period:

If any of these criteria are met, the Peak/Demand Surcharges apply until further notice to all Large Packages and packages requiring Additional Handling. ⁶ Applies to customers whose combined volume of Ground Residential and SurePost packages has exceeded 25,000 packages in any week after February 2020, regardless of the volume of customer's shipments for any particular service level. Once this threshold has been met, the Peak/Demand Surcharges apply until further notice to all service levels. Customer's volume includes any affiliated accounts and other accounts related to customer, as determined by UPS in its sole and unlimited discretion. The Peak/Demand Surcharges apply to all Ground Residential and SurePost packages in any weekly invoice period exceeding 110% of the customer's average weekly volume for the applicable service level for February 2020 (February 2 through February 29, 2020). For holiday weeks that are not full UPS operating weeks, the surcharge will apply to all packages in that weekly invoice period exceeding 110% of the customer's average daily volume for the applicable service level for February 2020 multiplied by the number of full UPS operating days in that week. If customer's average weekly volume for the applicable service level from August 29, 2021 through October 2, 2021 is less than 80% of its average weekly volume from February 2, 2020 through February 29, 2020, as determined by UPS in its sole and unlimited discretion, then customer's average weekly volume from August 29, 2021 through October 2, 2021 will be used for purposes of applying the Peak/Demand Surcharge for that service level for the remainder of the Peak/Demand Period. Customer's volume includes any affiliated accounts and other accounts related to customer, as determined by UPS in its sole and unlimited discretion.



UPS[®] Peak/Demand Surcharges

N. Peak/Demand Surcharge – Applied to UPS[®] Air Residential, UPS[®] Ground Residential and UPS SurePost[®] Packages

A Peak/Demand Surcharge will apply to certain UPS Air Residential,⁷ UPS Ground Residential⁷ and UPS SurePost packages, for customers who are billed for more than 20,000 packages during any week following October 2021.⁹ The Peak/Demand Surcharge amounts below will apply on a weekly basis to each package over 105% of the Baseline⁸ weekly average volume for each service level, during the specified Peak/Demand Period.⁹ The highest surcharge amount applicable to the volume in excess of the Baseline weekly average volume in a given week will apply to all packages over 105% of the Baseline weekly average volume in that week within each service level:⁹

⁸ The "Baseline" volume is the customer's average weekly volume for the applicable service level for June 2022 (June 5, 2022 through July 2, 2022). If customer's average weekly volume for the applicable service level from September 4, 2022 through October 2, 2022 is less than 80% of its average weekly volume from June 5, 2022 through July 2, 2022, as determined by UPS in its sole and unlimited discretion, then customer's average weekly volume from September 4, 2022 through October 2, 2022 will be used as the Baseline volume.

⁹ Applies to customers whose combined volume of Ground Residential, SurePost, Next Day Air Residential and All Other Air Residential packages has exceeded 20,000 packages in any week after October 2021, regardless of the volume of customer's shipments for any particular service level. Once this aggregate threshold has been met, the Peak/Demand Surcharges apply until further notice to all service levels. The Peak/Demand Surcharges apply to all Ground Residential, SurePost, Next Day Air Residential and All Other Air Residential packages in any weekly invoice period exceeding the Baseline volume for the applicable service level. For each service level each week, the amount of the surcharge for all packages over 105% of the Baseline for each service level is the highest applicable surcharge for the service level. For example, if the shipper has volume in a week of 175% of the Baseline average weekly volume for UPS Ground Residential, then each UPS Ground Residential package over 105% of the Baseline average weekly volume for UPS Ground Residential will be assessed a surcharge of \$2.00 (not just those over 150% of Baseline average weekly volume for UPS Ground Residential). For holiday weeks that are not full UPS operating weeks, the surcharge will apply to all packages in that weekly invoice period exceeding 105% of the customer's average daily baseline volume for the applicable service level multiplied by the number of full UPS operating days in that week. Customer's volume includes volume from any affiliated accounts and other accounts related to customer, as determined by UPS in its sole and unlimited discretion.
